Dear Dr. Vasile,

In response to your letter of November 16, we confirm that the above model Heat Reclaimers were tested by UL in July of 1992, and received UL Listing with a report issued on July 21, 1992. Please refer to the attached copy of the test record for the test performed. In addition, we have attached the test record from the previous generation models 2400, 3600, 4800, 6000 and 7200 which illustrate the Vented Wall Continuity Test, not required on the newer models. \*

UL Listing was withdrawn on the current models on July 19, 1994 per the request of Smart Drain, and they are not currently Listed.

To reinstate Listing, a request would need to be made along with a request for the change in name and address of the Applicant company from Smart-Drain to Water Film Energy Inc. Notification of factory locations would also be required.

If the test report is sufficient, UL Marks are not going to be applied to the products, and Follow-Up Service Inspections are not required, then Listing will not need to be reinstated. Please confirm which route you wish to pursue.

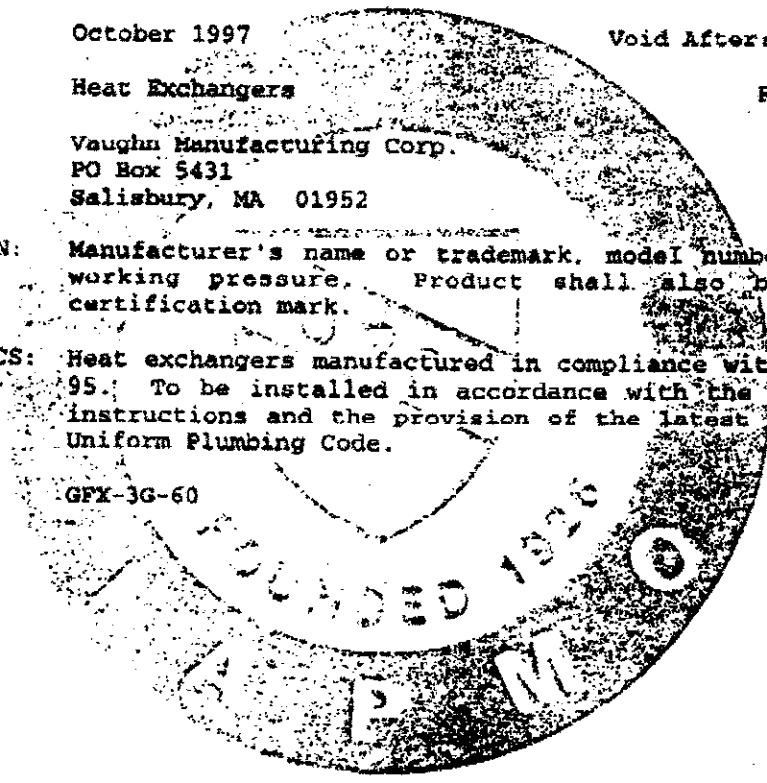

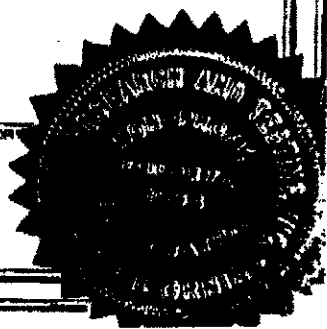
